## **Office Order**

In pursuance of decision taken in the meeting held on 10.10.2007 under the Chairperson of Mrs. Kiran Choudhry, Hon'ble Minister for Environment on 10.10.2007 at 10.00 AM in the Conference Room of Haryana State Pollution Control Board at Panchkula of the following decisions regarding collection/testing of samples were taken which shall be followed by all the Laboratories recognized by the Board including the Board's Laboratories as under:

- 1 The samples of Highly Polluting Industries, Industries covered under Environment Impact Assessment (EIA) notification, stone crushers, hot mix plants and mining will be got collected/tested only by Board Labs and not by Private Labs.
- 2 All kinds of samples will be collected by a team of 3 persons including a representative of concerned laboratories i.e. two officials from the Region and one from Laboratory of the Board.
- 3 The samples drawn by Private Labs will be got inspected by a team atleast of 3 officials of the Board on monthly basis which shall consist of one official of Head Office and two official of Regional Office concerned.
- 4 If any RO has any adverse observation about the samples passed by the private labs the same may be referred to the Head Office.
- 5 The Regional officers should be personally present for collection of samples of top 10 highly polluting industries.
- 6 The details of samples collected/tested/pending shall be furnished by the Board in the meeting.
- 7 For samples to be collected by private recognized laboratories, two officials of concerned Region and one representative of the Laboratory shall collect the sample.

All R.O.s/Laboratory Incharges are directed to follow the above procedure for collection of samples as mentioned above. Further the RO may associate one official from the adjoining Region, in case there is no laboratory in his Region. Regional Officers will do videography of inspections carried out by them. The sampling data shall be submitted by all Regional Officers/Laboratory Incharges to the Head Office which shall be compiled by SC-III and put up in the R.O.s meeting.
